  - Could change up the marketing, the timing, do at annual meeting
- o Changing the questions resets the multi-year data story
- o Decision:
  - Try the audit this year
  - Try having people try the survey at Annual Meeting, QR code, raffle ticket
  - Committee next year to rewrite the survey
  - Survey would have to be ready for June 1<sup>st</sup>
